

The Skills Audit: Why is measuring your skills and experience important?

Following the Spring Academy Council meetings, governors have been asked to complete their Annual Skills Audit return. But why do we ask you to do this?

Highlighting need

Regularly reviewing your council's effectiveness means that you can quickly flag where things aren't working as they should, or where there are weaknesses in knowledge or skills. It's important to remember that effective governance is the sum of many basic tasks and duties and doing these smaller tasks well matters. Identifying manageable tasks and steps by reviewing your effectiveness means great governance doesn't need to feel overwhelming.

Developing in the role

As a governor, you'll want to make sure that you have the skills and knowledge you need and that you have access to the appropriate training to fill any gaps. The best boards contain people from a diverse range of backgrounds and with different skills, so everyone can bring something different to the board.

You might also have people on the board who have skills or experiences that you're unaware of – and you'll want to make the most of these.

By keeping a record of how various committees and councils have grown their skills, we have the got the evidence ready for any board evaluations, external reviews of governance or Ofsted visits.

What does the guidance say?

Academies: the academy trust handbook (section 1.27) sets out that established trusts should include a review of the board's composition in terms of skills, effectiveness, leadership and impact in its governance statement.

SCHOOL IN THE SPOTLIGHT: Heatherwood Secures Residential Trip to Bendrigg for Post-16 Students

Heatherwood School's recently visited Bendrigg Trust: Residential Activity Centre; specialist residential activity centre for disabled people, as part of a taster session ahead of an exciting opportunity for their Post-16 students.

Headteacher, Deputy Head, and a class teacher spent the last weekend in February experiencing the centre's accessible activities firsthand. Their visit confirmed what an incredible place Bendrigg is for young people with complex needs.



Thanks to successful charity funding and bursaries, Heatherwood has secured a two-night residential stay in February 2026 for their Post-16 learners with profound and multiple learning disabilities (PMLD). The trip, covering six students and ten staff, would typically cost over £4,000. The huge positive being families will only need to contribute £60 to secure the experience for their children.

Bendrigg Trust provides fully accessible outdoor adventure experiences, giving disabled individuals the chance to participate in activities such as climbing, canoeing, and zip-lining in a safe and inclusive environment. The upcoming trip will allow Heatherwood's Post-16 students to engage in these experiences, helping to build essential life skills. With the booking now secured, Heatherwood is looking forward to a memorable and meaningful residential stay next year.

STAFF PARLIAMENT UPDATE

Staff Parliament convened on 26 February 2025 and discussed:

Wellbeing and Schools Bill: Staff were presented with a breakdown of how the government's 'Wellbeing and Schools Bill' could impact on Trust schools. They discussed new powers for Ofsted, Local Authorities and the Department for Education.

Parental Leave Policy: The Panel got advanced sight of the Parental Leave policy with new amendments around premature births. The Trust has a new initiative to provide affected staff more support. The latest version of the policy is on the website.

Enterprise Learning Institute: The group discussed the launch and the internal CPD offer. The group discussed the information staff have received regarding the offer and outlined concerns with having to cover staff to attend these courses. The group agreed that there would be more communications about ELI and were reassured support would be provided to cover
