Well, things have certainly been a little different since I issued my last briefing in the second spring term. Whilst the wider societal impact of the COVID-19 crisis has affected everybody's way of life, we in the state education sector have had the confusing situation of all schools being officially closed (as instructed by the Government), with most schools continuing to remain open (as instructed by the Government). Whilst all of our academies have been coming to terms with a new "normal" over the past 7 weeks, it has been different from one school to the next and most certainly not without its challenges.

It is with great sadness that I have to share the news that two of our pupils at Hilltop, Molly Niland and Marcela Havrilova, have died recently. Molly & Marcela were much loved children by their class teams and by the wider school community. Our thoughts and prayers are with their families during this sad time.

I know that many people are having to cope with the loss of loved ones, and many more are struggling with the heightened stresses and anxieties of living through a pandemic and the social distancing measures we've had to adopt. Naveen was a governor of Hilltop and Kelford back when Nexus was first formed, and has a son who has attended Hilltop for many years. Naveen has for the past 18 months been a governor at Pennine View, so he knows our Trust and our schools well. Gill is a procurement consultant who sought out the opportunity to join the Board so she could make a contribution to the state education system. Directors are unpaid volunteers who carry a lot of legal responsibility for our Trust and our academies, so I'm incredibly grateful that both Naveen and Gill have joined the Board.

Thank you to all our staff for all you're doing in these unprecedented times to support our children and families. Where families need us, we continue to be there for them. I couldn't be prouder.
